Arrangements for September 2021

Dear parent/guardian

First of all, I hope that all members of the School community have had a restful summer. This letter sets out the arrangements for the beginning of the autumn term. School attendance is mandatory for all pupils of compulsory school age and it is a priority to ensure that as many children as possible regularly attend school.

Control measures and arrangements

Step 4 of the government's roadmap marked a new phase in the government's response to the Covid-19 pandemic, moving away from stringent restrictions, towards advising people on how to protect themselves and others, alongside targeted interventions to reduce risk. As COVID-19 becomes a virus that we learn to live with, there is now an imperative to reduce the disruption to children and young people's education.

The DfE have produced a <u>guide</u> for parents, and the table below sets out the main changes in school from September 2021. A copy of our <u>risk assessment</u> is available on the school website, which includes our 'Outbreak Management Plan'.

Face	Face coverings are no longer advised for pupils, staff and visitors either in classrooms or in communal		
coverings	areas. The government has removed the requirement to wear face coverings in law but expects and		
	recommends that they are worn in enclosed and crowded spaces where you may come into contact		
	with people you don't normally meet. This includes public transport and dedicated transport to school		
	or college.		
Close	DfE guidance:		
contacts	 Settings only needed to do contact tracing up to and including 18 July. Close contacts will now 		
	be identified via NHS Test and Trace and education settings will no longer be expected to		
	undertake contact tracing.		
	 As with positive cases in any other setting, NHS Test and Trace will work with the positive case 		
	and/or their parent to identify close contacts. Contacts from a school setting will only be traced		
	by NHS Test and Trace where the positive case and/or their parent specifically identifies the		
	individual as being a close contact. This is likely to be a small number of individuals who would		
	be most at risk of contracting COVID-19 due to the nature of the close contact. You may be		

contacted in exceptional cases to help with identifying close contacts, as currently happens in managing other infectious diseases. Individuals are not required to self-isolate if they live in the same household as someone with COVID-19, or are a close contact of someone with COVID-19, and any of the following apply: they are fully vaccinated they are below the age of 18 years and 6 months they have taken part in or are currently part of an approved COVID-19 vaccine trial they are not able to get vaccinated for medical reasons Instead, they will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test. We would encourage all individuals to take a PCR test if advised to do so. Staff who do not need to isolate, and children and young people aged under 18 years 6 months who usually attend school, and have been identified as a close contact, should continue to attend school as normal. They do not need to wear a face covering within the school, but it is expected and recommended that these are worn when travelling on public or dedicated transport. 18-year-olds will be treated in the same way as children until 6 months after their 18th birthday, to allow them the opportunity to get fully vaccinated. At which point, they will be subject to the same rules as adults and so if they choose not to get vaccinated, they will need to self-isolate if identified as a close contact. This is crucial part curricular of our educational offering. activities Residential Residential activities can resume and are encouraged. activities **Travel** Anyone travelling to England must adhere to travel legislation, details of which are set out and in government travel advice. quarantine Those aged 11 to 17 need proof of a negative COVID-19 test to travel to England (children aged 10 and under are exempt from this) and those aged 5 to 17 must take a COVID-19 travel test on or before day 2. More information is provided in the government's quarantine and testing guidance. Additional guidance has been issued on the quarantine arrangements for boarding school pupils travelling from red-list countries to attend a boarding school in England.

COVID-19 testing for pupils on return to school

Testing remains important in reducing the risk of transmission of infection within schools. As pupils will potentially mix with lots of other people during the summer holidays, all secondary school pupils should receive 2 on-site lateral flow device tests, 3 to 5 days apart, on their return in the autumn term. Please see the separate letter regarding exact arrangements for testing.

Transport and arrival/departure

It is really important that the students stick to their designated times for arrival and departure. The government has produced <u>guidance on the use of transport</u> which is important to read and understand. Information on the Green Bus can be found on their <u>website</u>.

I have written extensively in the past about considerate parking and driving around the school and this is vital as we begin a new term and the staggered starts and finishes have come to an end. We continue to work with the local authority and police in making sure that the area around the school is a safe as possible. Please consider alternatives to driving and dropping off outside the school.

Arrangements for the start of term

The specific details for return are set out below. Students should enter the site via the main pedestrian gate or the CPA gate, from 8am. Please see the table above for guidance on where they should go when entering the site.

Uniform, lockers and sports store orders

We are expecting all students to return to school in full uniform, as this is an important part of our ethos. Students may wear their QM sports kit (including a full tracksuit) on the day in which they have a games afternoon (see table below), but not on days when they have PE or swimming. Students should not come into school in non-QM branded sportswear.
