Dear Parent/Guardian,

I hope that this letter finds you well and that you have had a good summer. Welcome to those students who are joining us for the first time and welcome back to those returning; I hope that the summer has reinvigorated you and you are ready to make a success of this year. We have been delighted to celebrate the successes of our GCSE and A-level students over the break, the headlines of which can be seen on our website and X account. We have had a team of students in Malawi, as part of a month-long expedition (see right). They had a magnificent experience and were a real credit to the school. The army cadets also took part in their annual summer camp and I have heard some really positive feedback back from the staff involved. Finally, we are pleased to announce that the Future Sport project is underway, with



the field fenced off ready for the development to start in the next couple of weeks. There will be some changes to student routines, which will be communicated at the start of term.

Attendance requirements

School attendance is a legal requirement. Absence negatively impacts a child's academic potential and performance and denies them the opportunity to interact socially with their peers and build experiences beyond the classroom. All pupils should aim to attend school 100% of the time. Attendance and punctuality continue to be monitored rigorously and as of September, we will maintain the approach introduced last academic year, in line with the <u>mandatory guidelines</u> published by the Department for Education. This includes:

- The daily sharing of attendance data with the Department for Education.
- Updated fine rates for unauthorised absence.
- Clear thresholds for penalty notices.
- Clear support and challenge to address any punctuality issues

Term-time holidays will not be authorised. We are obliged to consider issuing a penalty notice to parents if a child misses five days of school due to unauthorised absence. Where attendance or punctuality causes concern, appropriate levels of challenge and support will be implemented. If a child's attendance falls below 90%, they are classed as persistently absent. In such cases, the school will liaise with the Local Authority and an Education Welfare Officer, who may initiate legal proceedings if parents/carers are not meeting their legal obligation to ensure their child attends school. Our priority remains to take a 'support-first' approach, working with students and families to overcome any barriers to attendance. Behaviour expectations

We are proud that Ofsted rated our behaviour and attitudes as Outstanding, and we remain fully committed to maintaining these exceptional standards across all aspects of school life within lessons, during trips and activities, and while travelling to and from school. Our policies are available on the school website, and we ask all students to uphold our CREDIT values and embrace our atomic habits (page 3). Atomic habits are the small, seemingly insignificant things which if done consistently lead to positive outcomes. By setting high expectations for behaviour, we foster an environment that promotes both academic excellence and personal wellbeing. During the last academic year, we introduced several key changes to strengthen our approach to behaviour which we will continue to embed this year:

- A structured response to classroom disruption: following a warning and behaviour point, students can expect to receive Same Day Detention if disruption persists. This reinforces expectations and minimise loss of learning.
- Any unauthorised use of mobile phones result in a Same Day Detention.
- Persistent disruption is addressed with appropriate consequences and targeted support to helps students engage
 positively with school life.

We continue to take a clear and consistent approach to behaviour, offering support where needed while maintaining high standards that define our school community. Your support is greatly appreciated in this area.

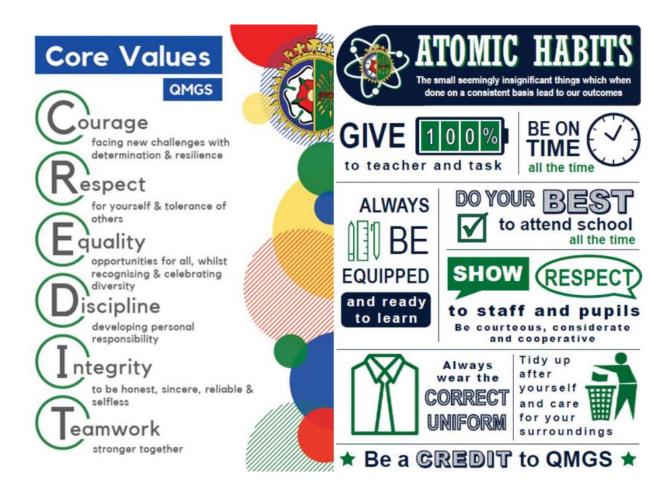

Parking & Driving around the school site

My Senior Leadership Team are on duty outside the school on Sutton Road at the beginning and end of each school day to keep our children safe. Regrettably that job was made difficult last year due to the dangerous driving and parking of a small but significant number of parents. Similarly the school regularly receives complaints from our neighbours about inconsiderate parking preventing them from accessing their properties, and from others about the poor standard of driving.

May I therefore reiterate the following points which have been made previously on several occasions:

- We encourage students to walk or cycle to school. This sustainable form of travel also promotes health. The school has secure cycle storage facilities
- We strongly encourage use of public transport. We are well served by the local bus network. West Midlands Travel offer good value termly bus passes for students which can be used for any journey, not just for school.
- If you do drive your child to school, you should arrange to drop and collect them away from the school site and let them walk the final part of the journey. This will alleviate the pressure of traffic immediately around the school.
- If parking in the local area you must follow the highway code. Parking on yellow zig-zags, in bus stops, across crossing areas, within 10m of a junction or in front of an entrance to a property are all prohibited. Please show consideration and respect to our neighbours and other road users.
- You must not stop in flowing traffic to allow passengers to get in or out of your vehicle. My staff see this extremely dangerous practice happening daily.
- You should not perform U-turns immediately outside the school as this causes obstruction to other vehicles.

We already work with the Local Authority to promote road safety and sustainable travel amongst our students. You should be aware that we proactively invite the police and parking enforcement teams to visit the school at peak times and issue penalties to drivers who are breaking the law.

I realise that the majority of parents already drive safely and considerately. Unfortunately the behaviour of a significant minority of parents is currently placing the safety of all students and staff at the school at risk. As we enter the darker winter months it is important that this situation is addressed.

Catering updates

Please see a letter on the next page from our catering partner, Innovate. All price tariffs, menus and other information will be available via the School website. There are a few updates/reminders for September:

- 1. **Free school meals** the allowance has increased to £2.75 per day and rolls over each day, re-setting at the end of the week. There should be clearer labelling of meal options.
- 2. **Pre orders** we would like to encourage greater uptake of pre-orders this year. Students can make their choices up to breaktime and collect their food, without queuing, at lunchtime. Please encourage this, especially for students taking part in lunchtime activities.
- 3. **Breakfast bagels** these will continue to be available from 8-8.30am each day in the canteen, free of charge for all students

Dear Parent/Guardian

IFG proudly serves over 400,000 students nutritious meals each day. Our award-winning teams are dedicated to serving vibrant, appetising food, freshly prepared on site using quality ingredients. To enable us to continue to do this, our **meal tariff will be increasing by 2.3% and Free School Meal Allowance to £2.75** from September 2025. The great news is we have frozen all our fruit, yoghurt and salad dish prices for another year. Below we have outlined some of the cost pressures which have driven this increase.

Food Inflation due to NI increases: We buy British and support our local economy where possible and because of Employers National Insurance increasing, this has meant we have received increases of 5%+ from our suppliers. The increase is not only the cost of delivering to our sites but also the products we purchase. We have robustly negotiated and mitigated with our suppliers, ensuring we maintain quality, however the NI increases have meant an underlying increase across all products and ingredients we buy.

Employee Funding & Retention: In April, the Government increased the minimum wage by 6.7%, a positive move which will ease cost pressures for many of our colleagues. Alongside this, to retain and attract a high standard of leadership, we have increased wages for supervisory and managerial roles. Despite positive advancements, the combination of these factors means significant ongoing cost demands across our industry, many of which we have absorbed.

We continue to seek ways of mitigating the costs associated with these challenges, however, we refuse to compromise on ingredients or service standards. We remain proud to serve a home cooked main meal and dessert, as well as other options. We truly believe we offer students innovative dishes which rival the high street whilst providing families with great value for money.

Through partnering with schools, we continue to see more students enjoying our services. Whilst this is great news and tells us our menus are popular with students, we are always looking to encourage more young people to dine with us. If you have any feedback we would love to hear from you.

We hope you understand our position and your family can continue to enjoy our services. We remain open and honest about our challenges and will continue to seek your input. Should you wish to discuss this letter, or anything else relating to your catering service, please get in touch.

Building work

As mentioned at the start of the letter, the building work for the Future Sport project is starting. There may be some disruption for work traffic, but we are working with the contractor to minimise this around busy drop off/pick up times.

There will be a change to student routines for the use of the school field:

- 1. The assembly point for fire alarms will be on the QMHS field (next to the main car park). We will hold a drill early in the term
- 2. There will be a rota for the use of the QMHS field during lunchtimes
- 3. All rugby during games afternoons and fixtures will take place at Walsall RFC. Students will be walked to the rugby club and dismissed from there. More information will follow from the PE department.

QM experience fund

We launched the QM Experience Fund last year and received a tremendous response, raising over £10,000. Added to just under £20,000 raised through the QMA events, this was a terrific boost to the school from the parental/student body and has made a genuine difference to what we can achieve.

As I have written to you about previously, over the past three years, we have been fundraising towards the <u>Future Sport</u> <u>@ QMGS project</u>: an ambitious initiative to revolutionise our facilities for the benefit of our students and the wider community. Any donations to the QM experience fund will initially go towards this, but will support a wide range of other opportunities once we have completed the project. Work started on the project at the end of August and we are hoping to have the astro-turf in use before Christmas.

I hope that you will seriously consider making a regular payment to the QM Experience Fund. We are grateful for a regular contribution as it enables us to plan the best ways in which to support our young people. Please follow this <u>link</u> for details of how to set up a standing order to the donations account and a Gift Aid declaration which, if you are a UK taxpayer, will allow us to claim an additional 25% on top of your donations. Alternatively, if you would prefer you can make a one-off annual payment (£75) or termly payments (£25 per term), you can do this via Parent Mail. Please select the 'QM Experience' option.

PARENTS/CARERS

As part of the partnership with the school, I/we will:

- Support the values and ethos of the school, including encouraging our child to strive for their best and to be actively involved in our community
- Respect all members of the community and be reasonable in expectations (in line with the Mercian Trust's parental code of conduct)
- Ensure that our child strives for 100% attendance at all times, is properly equipped and arrives well-ahead of the start of the school day at 0845
- Inform school of any absence on each day of absence and provide written confirmation by letter or email on their return
- Provide requests for planned absence well in advance (3 days)
- Not book holidays in term time and be aware of the legal responsibilities for <u>school attendance</u> and the School's <u>attendance policy</u>
- Be aware that although students may enter from 08:00 they may not be directly supervised until school starts at 08:45. After school hours, students may only remain on the school site after 16:00 if participating in an organised school activity or at homework club
- Support a healthy lifestyle for my child by encouraging healthy exercise, eating and sleep habits
- Make support that students have digital access in the home environment and communicate with the school if there is an issue with this
- Encourage digital responsibility and be vigilant over online use, using filters and parent restrictions as appropriate
- Accept that any property brought into school, including mobile phones, are done so at our own risk
- Support the School's **Behaviour Policy**
- See that my child completes work set, monitor their progress, and support them in their work and organisation
- Ensure that my child wears correct uniform and that all items are clearly and permanently named
- Keep the school informed about any concerns or problems that affect my child and any changes in contact details.
